CORRIGENDUM

That in compliance of Hon'ble Punjab & Haryana High Court order dated 9.9.2010 passed in a bunch of writ petitions including CWP No. 8604 of 2007 titled as Surender Kumar Mishra and others Versus State of Haryana and others, the seniority list of the H.E.S.-II Officers (College Cadre) was finalized after taking into consideration of all the objections filed by the aggrieved candidates, vide order dated 26.11.2020. Though, said seniority list was published after due care and caution, despite the facts, the department received some more objections. 
