

A meeting was held under the chairmanship of the Chief Electoral Officer, Haryana with the members of the State Steering committee on Accessible Election for the upcoming General Election to Lok Sabha, 2024. The Members of the committee and officers attended the meeting. Following direction were given to the departments for making elections accessible to PwD electors:-

- 1. Education department was requested to check the availability of ramp with proper gradient of 1:10, drinking water, lighting, furniture, toilets (PwD friendly). Also educate the student for motivating their family members for voting on day of polling. Educate the students about voting procedure by creating dummy polling booth. They are also requested to get the prints of comic Chacha Chaudhary and Chunavi Dangal and distribute it among the students.
- 2. The Social Welfare department was requested to arrange the camps in collaboration with District Election Officers for the enrolment of left out PwD beneficiaries in the electoral roll and make all the PwD electors. aware about Sakhsham App and voting through Postal Ballot from home by distributing Pamplets among the PwD voters.
- 3. The Red Cross Society was requested to provide wheelchairs, NCC, NSS volunteers at each polling station to help the PwD voters and senior citizen (85+) voter.
- 4. The PwD Department was requested to provide a proper gradient ramp of 1:10 inclination ratio and 1:14 firm hand rails at each Polling Station.
- 5. The Health Department was requested to provide proper medical kits at the booth alongwith doctor's team and also provide cashless medical treatment to polling personnel.
