No. G.S.R.27/Const./Art.309/1994--- In exercise of the power conferred by the proviso to article 309 of the Constitution of India, and all the powers enabling him in this behalf, the Governor of Haryana hereby makes the following rules further to amend the Haryana Education (College Cadre) Group B Service Rules, 1986, namely:-

- 1 These rules may be called the Haryana Education (College Cadre) Group B Service (First Amendment) Rules, 1994.
- In the Haryana Education (College Cadre) Group B Service Rules, 1986, (hereinafter called the said rules), in Appendix-A against Sr. No. 1 & 2, under column 6 for the existing entries, the following entries shall be substituted, namely:-
 - (i)Scale2,200-75-2,800-100-4,000(ii)Senior Scale3,000-100-3,500-125-5,000(iii)Selection Grade.3,700-125-4,950-150-5,700
