May please peruse the subject cited above.

I have been directed to inform and request you that in continuation to this office letter No. 15/151-2018 C-I(5) dated 19.07.2019 you are requested to take necessary action immediately byre fixing the salary of the petitioners in CWP No. 5975 of 2015 (list of Petitioners attached) as per the above mentioned letter.

It is however, intimated that in CWP No. 5975 of 2015 the Hon'ble Punjab and Haryana High Court has issued directions dated 07.09.2017 and the same are reproduced as under:-

"... The benefits be granted to the petitioners, within a period of 3 months from the date of receipt of a certified copy of this order, restricting the actual arrears to a period of 38 months prior to the date of filing the present petition."

In light of the directions of the Hon'ble High Court you are hereby directed to prepare the pay fixation proforma duly checked and verified by you along with the Service book and the calculation sheet for grant of arrears for a period of 38 month i.e., prior to 19.03.2015 (the date of filing the CWP No. 5975 of 2015).
