I am directed to invite your attention to the subject noted above and say that in pursuance of section 33 of The Right of Persons With Disabilities Act, 2016, the following categories of disabilities identified for the persons with benchmark disabilities alongwith physical requirements and functional Classification of the category for Haryana Civil Services (Executive Branch) are as under:-

The Chief Secretary to Government, Haryana Personnel Department will identify the posts in the establishment which can be held by respective categories of persons with benchmark disabilities under section 32 of the Act in HCS (EB) cadre by on administrative order. The words and expressions shall be same as defined in Annexure-A and as also contained in the Act.
