
Subject:- **Reservation of posts for Persons with benchmark disabilities under the service of State Government- Haryana Civil Services (Executive Branch) under Section 33 and 34 of "The Rights of Persons with Disabilities Act, 2016".**

Sir/Madam

I am directed to invite your attention to the subject noted above and to say that in pursuance of section 33 of The Right of Persons With Disabilities Act, 2016, the following categories of disabilities identified for the persons with benchmark disabilities alongwith physical requirements and functional Classification of the category for Haryana Civil Services (Executive Branch) are as under:-

Nature of disability	Functional Classifications i.e. types of disabled candidate who would be able to perform the physical requirements specified, but not necessarily the other physical requirements	Physically requirements which a candidate with 40% or more disability need to fulfil
Blindness or low vision	LV	MF,PP,S,ST,W,L,C,RW, H, KC,BN
	B	MF,PP,S,ST,W,L,C,RW (In Braille/software),H,KC,BN
Deaf and hard of hearing	FD,HH	PP,S,ST,W,L,C,RW,KC,BN
Locomotor disability including cerebral palsy, leprosy cured, dwarfism, Acid Attack Victims	OA, OL, BA, BH, MW, OAL, Cerebral Palsy, Leprosy Cured, Dwarfism, Acid Attack Victims	S,ST,W,SE,H,RW,C

2. The Chief Secretary to Government, Haryana Personnel Department will identify the posts in the establishment which can be held by respective categories of persons with benchmark disabilities under section 32 of the Act in HCS (EB) cadre by on administrative order. The words and expressions shall be same as defined in Annexure-A and as also contained in the Act.
