- 3. The amount will be the drawn by the Principal and will be disbursed and utilized for various activities mentioned in the scheme.
- 4. The expenditure shall be incurred in the following phases- 100% in a year.
- 5. Date by which the entire expenditure shall be completed by 28.02.2019.
- 6. Date by which the accounts should be rendered/compliance information given to the headquarter 28.02.2019.
- 7. Undertaking should be taken from the parents of the students.
- 8. Any other fee will not be charged from the students.
- 9. **Procedure to be followed** —The amount will be distributed by the Director Higher Education, Haryana, Panchkula depending upon the number of students and will be drawn by the Principal of the concerned Govt. College through their treasury. Record will be maintained by the DDOs concerned. Deputy Director, office of Director Higher Education, Haryana, Panchkula will monitor the progress for effective implementation of the scheme.
- 10. The College where the DD powers are allotted to Principal of a neighbouring college, that incharge Principal will draw the amount.
- 11. The Officer is responsible for implementing the scheme and the DDOs shall strictly follow the guidelines given below:-

Short trips/Fun trips & Educational Excursion Tours

These trips shall be organized by In-charges of various subject committees constituted in the colleges in the stream of Arts, Commerce, Science as well as Job-Oriented Courses. The trips may be of the duration of one day to three or four days. The students will visit the places/ sights of historical, geographical, scientific and commercial importance.
