

Subject: - To give employment, in various Departments/Boards/Corporations of Haryana Government, under Part-II of outsourcing policy (Engagement of persons on contractual basis) through the Saksham Portal.

Sir/Madam,

I am directed to refer to the subject noted above and to say that Employment Department has been implementing the Saksham Yuva Scheme- (Educated Youth Allowance and Honorarium Scheme-2016) to provide monthly Unemployment Allowance to educated youth and Honorarium to the eligible post graduate applicants for honorary assignment in various Departments/Boards/Corporations/Registered Societies etc. under Haryana Government and in Private companies/enterprises.

Upon consideration of the matter, Government has decided as follows:

1. All Departments/Boards / Corporations of Haryana Government shall hire persons for Group C vacant posts under Outsourcing Policy Part-II, through the Saksham Web Portal developed by Employment Department i.e. <https://hreyahs.gov.in>
2. All persons desiring to be engaged under Outsourcing Policy Part II shall register themselves on the Saksham Portal.
3. While applying for the job on Saksham Portal, the applicant shall mention his Saksham Portal registration number.
4. As per instruction dated 9.6.2016 (No. 16/7/2015-3GSII) the Departments/Boards/Corporations etc. are required to frame transparent selection criteria approved at level of Administrative Secretary. There shall be no written exam and interviews.
5. The applications shall be taken on Saksham Web Portal only. While applying for job on Saksham Portal, the applicants shall mention their Saksham Portal Registration number.
