



Sir/Madam,

I am directed to invite your attention to this department letter No. 5/10/2015-1AR dated 18.05.2016 on the subject noted above and to say that it has come to the notice of the Government that no action has been taken by departments on the following points till date:-

1. The Nodal Officer for website of the department/corporation should make sure that all the information requirement to be placed in public domain as per Section 4 of the RTI Act has already been placed on the website and Information is continuously at the earliest and a certificate to this effect should be given by HOD to this Department within week positively.
2. The information (Name, Designation and contact details) about the SPIO and First Appellant Authority both at headquarter and in the field must be prominently displayed on the website of the department and on the notice board in the front of O/o SPIO and Appellant Authority.
3. Head of Department, Nodal Officers will ensure that the applications received under RTI are being disposed off in time by sending the desired information to the applicant, so that number of appeals in the Commission could be decreased.

You are, therefore, requested again to ensure immediate compliance of above decisions and send a compliance report to the Government.
