

No. 9/12/2022-6-HBII.— "AYUSH" System of Medicine has emerged as leading healthcare service provider since many decades with various procedures especially Panchkarma, Ayurvedic Surgical & Para Surgical procedure like Kshar Shutra etc. The vast majority of Govt. employees, pensioners & their dependents have been undergoing treatment under AYUSH System of Medicine. State Govt. being committed to provide best healthcare facilities to its employees, pensioners and their dependents, is widening the scope of health services in AYUSH sector as well.

Accordingly; AYUSH Department, Haryana has brought out the 'AYUSH Medical Reimbursement Policy' containing therein, the fixed rate packages for various procedures, such as Panchkarma, Ayurvedic Surgery (Gynaecology, Eye/ENT, General Surgery) & Para-Surgery, Yoga, Naturopathy, Unani & Siddha; list of medicines admissible for reimbursement; and empanelment of private AYUSH Hospitals.

A. AYUSH REIMBURSEMENT POLICY:

1. AYUSH Reimbursement Policy will be governed by the Punjab Medical Attendance Rules, 1940 and regulations/instructions issued thereof from time to time.
2. Reimbursement of AYUSH treatment availed at Govt. AYUSH Hospital:
 - (i) Complete reimbursement will be allowed for indoor treatment availed at all the Government Hospitals located with in the State of Haryana; for Ayurveda/ Unani/ Sidha/ Yoga/ Naturopathy procedures, at the existing rates being charged.
 - (ii) Complete reimbursement will be allowed for indoor treatment availed at all the Government Hospitals located outside the state of Haryana, as per existing rates charged by concerned hospital, subject to the condition that the claimant would produce a certificate from the Medical Superintendent/Head of the Institution declaring it as a Government AYUSH Hospital/ Institution.
 - (iii) Medicines (as per Annexure "M"), consumables & disposables prescribed for procedures during indoor treatment will be reimbursed, subject to the certification of non-availability of such items in the AYUSH hospital by concerned Medical Superintendent/Incharge.
 - (iv) The final Medical bill shall be verified by treating doctor and countersigned by Medical Superintendent/ Incharge of AYUSH Govt hospital on 'Essentiality Certificate' duly filled and signed by claimant.

3. Type of private empanelled AYUSH Hospitals: These are divided into two categories:
- NABH Accredited AYUSH Hospitals
 - Entry Level NABH certified AYUSH Hospital
4. Reimbursement of indoor treatment availed at private empanelled AYUSH Hospitals:
- The patient availing indoor treatment in the approved/empanelled private NABH accredited AYUSH Hospitals & Entry Level NABH AYUSH Hospitals, located within or outside the State of Haryana, will be reimbursed as per the package rates fixed for NABH Accredited AYUSH Hospitals and Entry level NABH certified AYUSH Hospitals, respectively; along with room rent as per entitlement of the claimant fixed by AYUSH Department.
 - The reimbursement of Ayurvedic and Unani treatment will also be allowed for non-package procedure, for which, medicines as per Annexure "M", lab charges along with room rent fixed by AYUSH Department will be reimbursed according to entitlement of beneficiary of State Government. The base rates of reimbursable Ayurvedic and Unani medicines annexed at Annexure "M", shall be the rates fixed or as amended from time to time by IMPCL (a Central Government PSU) or actual rate (whichever is less) will be reimbursable.
 - The reimbursement of Homoeopathic treatment will also be allowed for non-package procedure as there are no packages under Homoeopathic treatment. The medicines as per Annexure "M", along with lab charges, room rent fixed by AYUSH Department, according to entitlement of beneficiary of State Government. The base rates of reimbursable Homoeopathic medicines annexed at Annexure "M" shall be the rates fixed by Goa Antibiotics & Pharmaceuticals Ltd. (Subsidiary of HLL Lifecare Ltd., A Government of India Enterprises) or any agency of Government of India or actual rate (whichever is less) will be reimbursable.
 - The rates not indicated in fixed rate packages in respect of items under the head of laboratory investigations/ diagnostic tests/ procedures shall be allowed at the 'PGI rates' for outside laboratories and at 'PGI rates+75% of the balance' for in-house labs; however, in no case these shall exceed the rates prescribed in Reimbursement Policy of Health Department (1340 fixed rate packages) vide notification dated 14.07.2020 and amended from time to time.
 - No prior permission/emergency certificate from AYUSH Department is required for availing indoor treatment at empanelled private AYUSH hospitals.
 - The duration of treatment shall not exceed 30 days for Ayurveda, and 28 days for Unani, Sidha, Homeopathy, Yoga and Naturopathy. For the treatment beyond fixed limit for same disease would require permission from the Committee, constituted under the Chairmanship of concerned District Ayurvedic Officer, on advice of treating doctor of empanelled AYUSH Hospital. However, the same shall not exceed 15 days in any case.
 - The re-admission for the same disease(s)/ medical condition after a gap of 30 days will again require permission of Committee, constituted under the Chairmanship of concerned District Ayurvedic Officer in the same year, on advice of treating doctor of empanelled AYUSH Hospital, only in exclusive & justified cases.
 - Expenditure on the treatment taken in the sub/chained branches/ sister concerns of the approved hospitals will not be reimbursed.
 - It is clarified that the procedures suffixed with package treatment in annexure A2 (AYURVEDA), Y2 (YOGA), N2 (NATUROPATHY), U2 (UNANI) & S2 (SIDHA) are "Fixed Rate Packages" and reimbursement shall be limited to the packages only.
 - No additional charge on account of extended period shall be allowed, when the extension of treatment has been necessitated due to improper management/ procedure.

B. AYUSH CHRONIC DISEASE POLICY:

The reimbursement of expenditure incurred upon treatment for AYUSH system of Medicine for chronic diseases on outdoor basis to Haryana Government Employees/Pensioners/Family Pensioners and their dependents will be governed on the following conditions:-

- The reimbursement of the expenditure for AYUSH treatment of chronic diseases on outdoor basis shall be limited to 18 chronic diseases, already notified by Health Department, Haryana vide letter dated 08.06.2005 (listed in para 2 below) and amended from time to time.

2. List of chronic disease/diseases already notified by Haryana Government
 - (1) Coronary Artery Disease
 - (2) Chronic Heart Disease
 - (3) Chronic Respiratory Disease (COPD, I&D, Cystic Fibrosis)
 - (4) Chronic Renal Failure
 - (5) Rheumatoid Arthritis and Osteo-Arthritis
 - (6) Brain Tumor and Malignancy of different organs
 - (7) Paraplegia/Quadriplegia/Hemiplegia
 - (8) Epilepsy
 - (9) Multiple Sclerosis/ Myasthenia Gravis/ Parkinson's Disease
 - (10) Ulcerative Colitis/Crohn's Disease/Coeliac Disease
 - (11) Cirrhosis of Liver/Chronic Hepatitis 'B' & 'C'
 - (12) Thalassemia, Haemophilia, Aplastic anaemia, Myelodysplastic Disorders
 - (13) Connective Tissue Disorder i.e. Wagner's Granulomatosis, Scleroderma, SLE & Polyarteritis Nodosus
 - (14) Psoriasis
 - (15) Diabetes Mellitus
 - (16) AIDS
 - (17) Glaucoma
 - (18) Organ Transplant
3. The certificate of Chronic Disease shall be issued by the Medical Board constituted under Civil Surgeon, as per instructions issued by Health Department, Haryana vide letter dated 14-07-2020 and amended from time to time.
4. The State Government beneficiary desirous of claiming reimbursement of AYUSH treatment of Chronic Diseases shall surrender Fixed Medical Allowance and opt for Open Medical Allowance. The claimant cannot avail Fixed Medical Allowance and reimbursement of OPD treatment for chronic diseases, simultaneously.
5. The State Government beneficiary can change option from Fixed Medical Allowance to Open Medical Allowance or vice versa at any time, by applying to Head of Concerned Department for the same.
6. The reimbursement will be allowed for the treatment availed at all the Government and private AYUSH Empanelled Hospitals/ Institutions, located within or outside the State of Haryana.
7. The Reimbursement of treatment under AYUSH system will be allowed for prescribed medicines, enlisted in "Annexure-M" and for laboratory tests/ investigations/ diagnostic tests/ procedures. The reimbursement for labs/ diagnostics shall be allowed at the 'PGI rates' for outside laboratories and at 'PGI rates+75% of the balance' for in-house labs; however, in no case these shall exceed the rates prescribed in Reimbursement Policy of Health Department (1340 fixed rate packages) vide notification dated 14.07.2020 and amended from time to time.
8. In case of Yoga & Naturopathy Hospitals, the reimbursement of few procedures, carried out on OPD basis, is allowed at the rates mentioned in fixed rate packages in "Annexure-Y2" and "Annexure-N2", respectively, or at the actual rates charged by private hospital, whichever is less.
9. The private empanelled AYUSH hospitals shall provide 40% discount in OPD consultations/ visiting charges. However, the reimbursement for OPD consultation/ visiting charges will not be allowed.
10. The reimbursement for OPD treatment shall be subject to the condition that concerned District Ayurvedic officer should approve the bill on Essentiality Certificate (as prescribed by Haryana Government) duly signed and stamped by treating doctor and countersigned by Medical Superintendent. In case of any doubt, the bills may be got approved by a Committee of experts.
11. The State Government beneficiary can choose the multiple treatment regimes/pathies for cure, however, reimbursement will be allowed for treatment availed under only one pathy, for a given time period.

C. EMPANELMENT OF PRIVATE AYUSH HOSPITALS WITH HARYANA GOVERNMENT.

To ensure the quality & standards of treatment at private AYUSH Hospitals, only NABH accredited/certified hospitals would be empanelled with State Government for a period of 3 years. However, as presently, only small number of private AYUSH hospitals possess NABH accreditation/ certification, Entry level NABH certified AYUSH Hospitals would also be taken on panel, subject to the condition that such hospital shall get NABH accreditation within one year failing any of the conditions would lead to automatic de-empanelment of such hospital, without any prior notice.

In view of the cost involved in NABH certification/accreditation and to motivate private hospitals for the NABH certification/accreditation, the fixed rate packages have been formulated for NABH accredited AYUSH Hospitals at highest rates; and for entry level NABH certified hospitals at 15% lesser rates.

1. NABH Accredited/Entry Level Certified AYUSH Hospitals:

- i. The AYUSH Hospitals/institutions possessing valid NABH accreditation would be empanelled for a period of 3 years, after which the hospital shall apply for renewal to continue empanelment.
- ii. The AYUSH Hospitals/institutions possessing valid Entry Level NABH Certification would be empanelled for a period of 1 year, initially and shall upgrade to full NABH within 1 year, after which the empanelment would continue for rest of the period i.e. a total of 3 years from the date of empanelment.
- iii. The hospital shall possess a valid NABH accreditation/ Entry level NABH certification during the whole period of empanelment with State Government and shall submit renewed NABH Accreditation/Entry Level NABH Certification before expiry, failing which it will be de-empanelled automatically, without any prior notice.
- iv. AYUSH Department, Haryana has full right for inspection of empaneled hospital if any complaint received against hospitals.

2. Process of application:

- a. The Application shall be submitted on online Portal for Empanelment for AYUSH Hospital, along with submission of physical application with all the necessary substantiating documents to the Director General, Department of AYUSH, Haryana Sector-3, Near Youth Hostel, Panchkula; along with certificate of Undertaking & list of essential documents(If Applicable), as mentioned below:
 - (1) Copy of certificate or Memo of State Health Authority recognizing the Hospital (if Clinical Establishment Act, 2010 is applicable on that hospital).
 - (2) Building Plan Approval/certificate/permission from competent Government Authority.
 - (3) Registration Certificate/License of Each X-ray Radiation Machine issued by AERB.
 - (4) Certificate from the Income Tax Department for Exemption of Income Tax.
 - (5) GST Certificate
 - (6) Photocopy of PAN Card.
 - (7) Name and address of the Bankers.
 - (8) Computerization of medical records: All the medical records must be computerized and readily available.
 - (9) Ambulance Service: In-house or outsourced (under MOU), with valid RC and Insurance.
 - (10) Pharmacy/Medical Store: In-house or outsourced (under MOU) with valid license.
 - (11) Ramp and Stairs/lift, with Registration under Haryana Lift and Escalator Act, 2008 and amendments thereof or Licence from Government Authority for lifts, as per applicability in the concerned State.
 - (12) Kitchen/Canteen with FSSAI certification or/and Certificate for Registration of Canteens under Prevention of Food Adulteration Act.
 - (13) Fire fighting system: NOC for fire safety issued by Government Authority
 - (14) Bio-medical Waste Management, as per BMWM Rules, 2016:
 - i. MOU with CBWTF for BMWM.
 - ii. BMWM Authorization Certificate from State Pollution Control Board.
 - iii. Consent to Operate under the Air Act and the Water Act from State Pollution Control Board.

- (15) Adequate parking space
 - (16) Hygienic surroundings
 - (17) Hospital/center should be easily accessible/Approachable
 - (18) 24 hrs Water supply
 - (19) 24 hrs electrical supply with proper back up
 - (20) Hospital must have all facilities located in the same premises and should not be in scattered building
 - (21) Any other Certificate/License required by AYUSH Department Haryana.
(15 to 21 to be certified by CEO/Medical Superintendent of the Hospital on letter Head)
 - b. Application forms should be submitted in one sealed envelope superscribed as 'Application for empanelment of AYUSH Hospital'.
 - c. The Applicant must mention the Speciality (AYUSH) or multi-speciality for which empanelment is required.
 - d. All the pages of application and annexure shall be serially numbered, signed and stamped invariably by authorized person of the Hospital.
 - e. As far as possible all information should be given in the application. If a particular facility is not available, it should be mentioned as "Not applicable".
 - f. Application that is found complete in all respects shall be forwarded to Committee for inspection/verification.
 - g. The case with valid documents will be submitted to Director General AYUSH for approval.
 - h. After approval, MOU will be signed between applicant Hospital and AYUSH Department, Haryana with submission of performance Bank Gurantee of Rs. 50,000/- (Rs. Fifty Thousand only).
 - i. A non-refundable application fee of Rs. 5000/- (Rs. Five thousand only) shall be paid in the form of Demand Draft payable in the name of "Director General, AYUSH Department, Haryana" from any Scheduled or Commercial or Nationalized Bank, along with application.
- 3. MEMORANDUM OF AGREEMENT (MOA)**
- The private AYUSH hospitals selected for empanelment will have to enter into an agreement with Director General AYUSH, Haryana for providing services to Haryana Government beneficiaries at the rates, prescribed by AYUSH Department Haryana & amended from time to time, for each of the category of hospitals i.e. NABH Accredited/ Entry Level NABH Certified.
- 4. Violation of MOU**
- In case of violation of any of the provisions of MOU by hospitals, as mentioned below:
- a. Refusal of service
 - b. Undertaking unnecessary procedures
 - c. Deficient or defective services
 - d. Over billing
 - e. Negligence etc
 - f. Reduction of staff/infrastructure/equipment etc. resulting in reducing facilities after the hospital has been empanelled.

The Ayush Department will have the right to de-empanel the hospital. Such action could be initiated on the basis of complaint, medical audit or random inspections carried out by teams of Ayush deptt. Haryana. In the first instance, a showcause notice will be issued to the concerned hospital for reply within 15 days of its receipt. Director General Ayush, Haryana will be the competent authority to pass appropriate orders based on the facts and circumstances of the case. However, hospitals will have the right to appeal within 30 days to Additional Chief Secretary, Health & AYUSH Department, Haryana whose decision will be final.

5. ELECTRONIC/COMPUTERIZED BILLING.

All Billings is to be done in electronic format and medical records need to be submitted in digital format. Hospitals that do not have the capacity or ability to comply with this condition will not be empanelled.

6. MEDICAL AUDIT

The hospitals will send a report to the office of Director General, AYUSH Haryana regarding the patients who have taken treatment from the hospital on quarterly basis. Medical Audit of the services provided by the empanelled hospital would be carried out on regular basis by the AYUSH department.

D. FIXED RATE PACKAGES FOR AYUSH TREATMENT:

- i. Fixed rate package means a lumpsum amount to be charged by empanelled private AYUSH hospital for standard set of procedures that are administered to the State Government beneficiary while undergoing treatment for a pre-diagnosed condition. There are 2 categories of rates on the basis of type of hospitals i.e. NABH Accredited and Entry Level NABH certified.

The fixed rate package includes all charges pertaining to a particular treatment/procedure including charges for registration, admission, cost of medicines/ contingency/ consumables, lab charges, kshar sutra operation/procedure, Doctor charges/Consultant visits, monitoring, operation theatre charges/consumables, procedural charges/Surgeon's fees, cost of disposable surgicals, nursing care, etc. from the time of admission till discharge.

- ii. The Pre-diagnosed conditions/ diseases/ disease conditions necessitating hospitalization of the patients, indicative therapies/ procedures and likely duration of hospitalization are mentioned in Annexure A1 (AYURVEDA), Y1 (YOGA), N1 (NATUROPATHY), U1 (UNANI) & S1 (SIDHA), the same shall be strictly adhered to by all the empanelled AYUSH hospitals. In a rare case, the reimbursement of procedure/therapy not mentioned in Annexure will be reimbursed only on certification of essentiality being issued by treating doctor.

- iii. It is clarified that the procedures suffixed with package treatment in Annexure A2 (AYURVEDA), Y2 (YOGA), N2 (NATUROPATHY), U2 (UNANI) & S2 (SIDHA) are covered under "Fixed Rate Package Treatment" and reimbursement shall be limited to the package rates.

- iv. Entitlement for Room and Room-Rent to be charged for each day of admission:

- v. Definition of Ward/Room:

- a. Private ward is defined as a hospital room where single patient is accommodated and which has an attached toilet (lavatory and bath). The room should have furnishings like wardrobe, dressing table, bed-side table, sofa set, and carpet, TV, Air conditioner, Intercom facility, etc. as well as a bed for attendant.
- b. Semi Private Ward is defined as a hospital room where two to three patients are accommodated and which has attached toilet facilities and necessary furnishings along with Air conditioner.
- c. General ward is defined as halls that accommodate four to ten patients with necessary toilet attachments and furnishings.

- vi. Accommodation in higher category than the entitlement of State Government beneficiary is not permissible. However, in case of an emergency when accommodation in the entitled category is not available, admission in the immediate higher category may be allowed till the accommodation in entitled category becomes available. However, the Hospital can charge only as per entitlement of the beneficiary.

- vii. In case, beneficiary opts for category over & above his/her entitlement for type of room/ward, it will be responsibility of the Hospital to explain and obtain undertaking from the beneficiary. The Charges over and above the entitlement will be borne by the beneficiary and shall be mentioned in the final bill.
- viii. No additional charge on account of extended period shall be allowed, if extension is due to any improperly conducted procedure or due to any unjustified complications.
- ix. The prescribed rates as indicated in Annexure A2 (AYURVEDIC), Y2 (YOGA), N2 (NATUROPATHY), U2 (UNANI) & S2 (SIDHA) may be revised from time to time by State Government, as and when required, and will be applicable from the date of such notification. Any such information would be immediately uploaded on the website of AYUSH department for information of all empanelled hospitals and general public.
- x. In case, multiple packages are invoked for treatment provided at same time, then the package rates shall be charged at following rates:
 - a. Highest package at 100%
 - b. 2nd package and all the subsequent packages at 50%
 - c. Packages will be limited to 3 packages per day only.
 - d. However, the room rent shall be charged once only.
- xi. It will be responsibility of the beneficiary to establish his/her identity verifying him/her to be State Government beneficiary, by producing relevant documents, such as Identity card issued by Head of Office, Aadhar No., Employee Code, PPO No. (in case of Pensioners), etc. The cashless portal, hosted on website of Health Department (haryanabehalf.nic.in) may also be utilized by empanelled hospitals for verification of State Government beneficiaries.
- xii. It will be responsibility of the concerned hospital to ask for ID card from the employee/pensioner and to explain to them that the procedures are covered under the fixed rate packages or not.
