Terms & Conditions

1. You are appointed purely on temporarily / provisional basis
2. Your appointment is against temporary posts and your confirmation against substantive posts shall be considered on the basis of your seniority and record of service as and when such posts are available.
3. If at any stage, you desire to resign from your post, you will be required to give one month's notice or forfeit in lieu thereof your salary including allowances for one month or for the period by which the notice falls short of one month. The Directorate will give such a notice to you also in case it is proposed to terminate your service for the reasons other than that mentioned in clause (1) above.
4. You will remain on probation for a period of two years from the date of joining in the department. The period of probation can be extended in accordance with the existing rules. For assessing their performance during the period of probation, your work and conduct will be taken into consideration.
5. 
