Whereas vide order No. DMC-SPO/5215 dated 02.05.2021, the State Executive Committee had declared a lockdown from 03.05.2021 (05:00 am onwards) to 10.05.2021 (till 05:00 am) and vide order No. DMC-SPO/5439 dated 09.05.2021, DMC-SPO-3093 dated 16.05.2021, DMC-SPO/5761 dated 23.05.2021, DMC-SPO-2020/6008 dated 30.05.2021 and subsequent order No: DMC-SPO-2020/6222 dated 06.06.2021, the same was extended as Mahamari Alert-Surakshit Haryana महामारी अलर्ट-सुरक्षित हरियाणा from 10.05.2021 (05:00 am onwards) to 17.05.2021 (till 05:00 am); 17.05.2021 (05:00 am onwards) to 24.05.2021 (till 05:00 am); 24.05.2021 (05:00 am onwards) to 07.06.2021 (till 05:00 am) and further from 07.06.2021 (05:00 am onwards) to 14.06.2021 (till 05:00 am) in the State of Haryana alongwith guidelines to be implemented during the period), respectively.

Now, after duly considering the fact although the Covid positivity rate and the number of new Covid positive cases have declined, so as to continue the preventive and the precautionary measures to contain the Covid pandemic, in exercise of the powers conferred under Section 22(2)(h) of the Disaster Management Act, 2005, the undersigned in my capacity as Chairperson, State Executive Committee hereby extends the Mahamari Alert-Surakshit Haryana 'महामारी अलर्ट-सुरक्षित हरियाणा' for another one week, i.e., from 14.06.2021 (05:00 am onwards) to 21.06.2021 (till 05:00 am) in the State of Haryana alongwith guidelines to be implemented (during this period) issued earlier vide order dated 02.05.2021 (DMC-SPO-2020/5215) and modified subsequently vide order dated 09.05.2021(DMC-SPO-2020/5439).

All Colleges, Coaching Institutions, ITIs, Libraries and Training Institutes whether Government or Private shall remain closed till further orders in the State.

However, the following relaxations are provided in modification of earlier order issued vide DMC-SPO-2020/6222 dated 06.06.2021:-

- a. All shops are allowed to open from 09 00 AM to 08:00 PM.
- b. Malls are allowed to open from 10:00 AM to 08:00 PM.
- c. Restaurants and bars (including in hotels and in malls) are allowed to open from 10:00 AM to 10:00 PM with 50% of the seating capacity and adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms. Home delivery from hotels, restaurants and fast food joints is permitted upto 10:00 PM.
- d. Religious places are allowed to open with 21 persons at one time with the condition that they follow requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.

- e. Corporate Offices are permitted to open with 50% attendance after adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms.
- f. Gatherings in weddings, Funerals/Cremations are allowed upto 21 persons. However, weddings can take place at places other than home and Courts also. No movement of 'Barat' procession will be allowed.
- g For gatherings other than weddings, funerals/cremations, the maximum number allowed will be 50. For gatherings more than 50, prior permission from the Deputy Commissioner shall be required.
- h. Club houses/ restaurants/ bars of the Golf Courses are allowed to open with 50% seating capacity from 10:00 AM to 10:00 PM with adherence to requisite social distancing and other safety norms. Members/visitors shall be allowed to play in Golf Courses by the management in a staggered manner so as to avoid overcrowding.
- i. Gyms are allowed to open from 06:00 AM to 08:00 PM with 50% capacity after adopting requisite social distancing norms, regular sanitisation and Covid appropriate behavioural norms. However, Spas shall remain closed.
- All production units, establishments, Industries are permitted to function.
 However they shall strictly adhere guidelines, behavioural norms.
- k Sports Complexes, Stadia are permitted to open only for sports activities(spectators will not be allowed). Sports Authorities shall ensure adherence of requisite social distancing norms, regular sanitisation of the premises and Covid appropriate behavioural norms.

The Deputy Commissioners of the concerned districts are hereby directed/authorised to work out the modalities of implementing the above mentioned relaxations strictly.

In continuation of this office order dated 17 04 2021, I have been directed to convey the order No. DMC-SPO-2020/5150 dated 29.04.2021 issued by the Chief Secretary-cum-Chairperson, Haryana State Executive Committee, Government of Haryana, Haryana State Disaster informed which vide Authority Management that the Covid 19 pandemic is again posing threat to public health, the Government of Haryana has co nsidered it necessary to take effective measures to prevent its spread in the State of Haryana enclosed). In accordance, it has been decided that all colleges and universities will remain closed upto 31 05 2021

The institutions will remain closed for all students and staff (teaching and non teaching) till 31st May. 2021. However, the staff will work from home, online classes will be continued for the monitoring of which the Head of the Institution shall make a plan/timetable. It shall be the duty of the teachers to inform students of the schedule of classes. The LMS wherever available shall be put to use by all faculty which will be monitored regularly by the Head of the Institution. Daily report of online classes by faculty shall be updated on the MIS portal by using login ids of the faculty of Government (mis higheredulty ac. in) and Aided Colleges (amis higheredulty ac. in). For Universities and Self Financing Colleges, the Head of the Institution will take reports from all faculties regarding classes taught by a teacher, lessons delivered, number of students present in each class, online assignment and submit reports on the MIS portal of Universities (stateuniversity higheredultry ac in) and ERP portal of self financing colleges (collegeerp higheredultry ac in).

The Head of the Institution is authorized to call all non teaching staff on staggered basis 50% of the total staff on alternate days. Similarly, the Head of the Institution is further authorized to call any teaching faculty in case of administrative exigencies, examination and evaluation related work on staggered basis as per requirement following COVID protocol. Universities may devise strategy for conduct of online examination, if deems appropriate by the University.

Now, after duly considering the fact that although the Covid positivity rate has come down, however the Mahamari Alert-Surakshit Haryana 'महामारी अलर्ट-सुरक्षित हरियाणा' needs to continue so as to it bring the same and the fatality rate down even further, in exercise of the powers conferred under Section 22(2)(h) of the Disaster Management Act, 2005, the undersigned in my capacity as Chairperson, State Executive Committee hereby extends the Mahamari Alert-Surakshit Haryana 'महामारी अलर्ट-सुरक्षित हरियाणा' for another one week, i.e., from 31.05.2021 (05:00 am onwards) to 07.06.2021 (till 05:00 am) in the State of Haryana alongwith guidelines to be implemented (during this period) issued earlier vide order dated 02.05.2021 (DMC-SPO/5215) and modified subsequently vide order dated 09.05.2021(DMC-SPO/5439).

All Colleges, Coaching Institutions, ITIs, Libraries and Training Institutes whether (Government or Private) shall remain closed upto 15.06.2021 in the State. Anganwadi Centers and Creches under Women and Child Development Department shall remain closed upto 30.06.2021.

However the following relaxations are provided in modification of earlier order issued vide DMC-SPO-2020/5761 dated 23.05.2021:-

- 1. Stand alone shops are allowed to open during the day when the night curfew is not in operation.
- 2. Shops other than stand alone shops are allowed to open from 09:00 AM to 03:00 PM in two groups namely odd and even- shops with odd numbers on odd dates and shops with even numbers on even dates.
- 3. Malls are allowed to open from 10:00 AM to 06:00 PM. However, the entry shall be regulated by the Malls, i.e., at a given time only 1 person per 25 Square feet is allowed, for this purpose the Malls shall develop 'Apps' to regulate the same. However cinema halls, restaurants and bars located inside the Malls shall remain closed.

4. Hotels are allowed to open with the condition that no banquets/conferences will be permitted. Restaurants, bars in hotels will also remain closed. Room occupancy is allowed.

The Deputy Commissioners are hereby directed/authorised to work out the modalities of implementing the above mentioned relaxations strictly.
