Subject:- SLP (CC) No. 13901 of 2013 converted into SLP No. 26907 of 2013- State of Haryana Vs. Satyapal Yadav & another together with SLP No. 26908-11, 32259, 34641, 34643, 34644, 36488 of 2013, 4766-67 of 2014, 6420-6425 of 2014.

In continuation of this office letters no. KW 3/3-2013 C-III (1) dated 19.06.2014 and 20.10.2014 on the subject cited above.

The State Govt. vide above mentioned letters has granted the benefit of fixation of pension/family pension in the corresponding scale of Rs. 37400-67000+9000 AGP w.e.f. 01.01.2006 notionally and arrear w.e.f. 01.11.2010 onwards to those lecturers who retired before 01.01.2006 and have completed 3 years service in selection grade i.e. Rs. 12000-18300 prior to their retirement and were respondents in SLP (CC) No. 13901 of 2013 converted into SLP No. 26907 of 2013- State of Haryana Vs. Satyapal Yadav & another together with SLP No. 26908-11, 32259, 34641, 34643, 34644, 36488 of 2013, 4766-67 of 2014, 6420-6425 of 2014.

The State Govt. in view of the judgments dated 10.07.2014 passed by the Hon'ble Supreme Court in SLP No. 26907/2013 filed by the State Govt. with other SLPs No. 26908-11, 32259, 34641, 34643, 34644, 36488 of 2013, 4766-67 of 2014, 6420-6425 of 2014 has reconsidered the matter and it has now been decided that the benefit of fixation of pension/family pension in the corresponding scale of Rs. 37400-67000+9000 AGP w.e.f. 01.01.2006 to the above mentioned lecturers who retired before 01.01.2006 and have completed 3 years service in selection grade i.e. Rs. 12000-18300 prior to their retirement be granted actually w.e.f. 01.01.2006 instead of 1.11.2010 by relaxing rules to that extent.


