



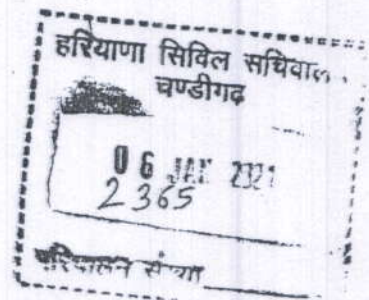

Subject: Online authorisation of GPF final payment cases.

1.0 Principal Accountant General (A&E) office through its Circular number Fund-1/Online submission fund cases/371 dated 11<sup>th</sup> August 2020 communicated the detailed procedure for use and submission of all GPF final payment cases of retiring Haryana Government employees ( not involving payment to nominees and/ or family member and AIS officers not having unique code) and will be submitted through a utility on Online Diary Management System

Principal Accountant General (A&E) office had through its Circular communicated the procedure of implementation of e-GPF authorities of final payment cases through which it was decided that communication of authorization of GPF final payment cases in respect of retiring Haryana Government employees will be issued online and e-GPF authorities will be transmitted to Treasury Offices/Sub-treasury Offices/DDOs and GPF subscribers through Online Diary Management System and Online Treasury Information System ( e- Pension) in a manner similar to e- PPO/ e RPTO.

1.2 Further, Principal Accountant General (A&E) office had through its Circular number Fund-1/Online authorization of GPF cases/20-21/780-86 dated 01<sup>st</sup> December 2020 communicated that till development of utility by NIC, e-GPF authorities will be made available to DDO/Treasury/Sub Treasury and GPF subscriber through e-mail.

2.0 In Para 3.3 of above mentioned circular number Fund-1/Online authorization of GPF cases/20-21/691-96 dated 3<sup>rd</sup> November,2020, it was communicated that NIC will pull the data from local ODMS server to NIC server and transmit them through Online Treasury Information System. NIC has developed the utility and from 1<sup>st</sup> January 2021, GPF Final Payment authorities in electronic form will be available through OTIS(to Treasury Officers) and Billing(to Drawing & Disbursing Officers).

- 3.0 Treasury Officers/sub treasury officers of Haryana Government Employees can download Authority through Treasury User of Online Treasuries Information System(OTIS).
- 4.0 All DDO's can download e-Authorities through e-Billing, Haryana at <https://esalaryhry.nic.in>.
- 5.0 A link is provided to GPF subscriber through SMS to download his/her copy of Authority, on his/her mobile.
- 6.0 e-Authorities will be sent via e mail mode only to Treasury Officers/sub treasury Officers/DDOs /Subscriber for all those DDO's whose IFMS code is not registered or not traceable by officials of O/o Principal Accountant General (A&E), Haryana.
- 7.0 Further, an additional copy of e-GPF authorities will also be made available to TOs, DDOs and GPF Subscribers on their login page of Online Diary Management System under the tab "Form PF-9 Application Status" for all those cases received through ODMS.
- 8.0 Similar ODMS facility for availability of e- GPF Authorities ( where applicable) to Income Tax Department is under development. Till such time the e-GPF Authorities to Income Tax Department (where applicable) will be sent to e-mail at [rohtak.cit@incometax.gov.in](mailto:rohtak.cit@incometax.gov.in).
