



Subject:- Guidelines regarding sending of cases to Finance Department to engage fresh contractual manpower through Haryana Kaushal Rojgar Nigam.

Kindly refer to the subject noted above.

2. It has been observed that large number of cases are being received in Haryana Kaushal Rojgar Nigam Cell (HKRN Cell), Finance Department from Departments for approval of contractual manpower through Haryana Kaushal Rojgar Nigam, whereas Departments have not entered correct data on e-post and HRMS.
3. Departments should scrupulously follow the instructions of Finance Department bearing No. 28/12/2012-1B&C (T&A) dated 08.06.2022 regarding "updating data in e-posting" while submitting the proposal to Finance Department for approval of contractual manpower through Haryana Kaushal Rojgar Nigam.
4. The proposal of Administrative Department will be entertained only after finalization of actual data about posts on the e-post module and HRMS.
