It has now been decided to include the following diseases in the list of Chronic diseases with immediate effect:-

1. Coronary Artery Diseases
2. Chronic Heart Diseases
3. Chronic Respiratory Diseases-COPD, ILD, Cystic Fibrosis
4. Chronic Renal Failure
5. Rheumatoid Arthritis & Osteo-Arthritis
6. Brain Tumours & Malignancy of different organs
7. Paraplegia/Quadriplegia/Hemiplegia
8. Epilepsy
9. Multiple Sclerosis, Myasthenia Gravis, Parkinson's Disease
10. Ulcerative Colitis/Crohn's disease/Celiac disease
11. Cirrhosis of liver, Chronic Hepatitis B&C
12. Thalassemias, Haemophilia, Aplastic Anaemia, Myelodysplastic Disorders.

1. Connective Tissue disorders-Wegner's Granulomatosis,
Scleroderma, S.L.E. & Polyarteritis Nodosa
2. Psoriasis
3. Diabetes Mellitus
4. AIDS
5. Glaucoma
6. Organ Transplant.

Preventive measures to contain the spread of Coronavirus (COVID-19)- Guidelines for protection and safety of Persons with Disabilities (Divyangjan) during COVID-19

Sir/Madam

I am directed to refer to the subject noted above and to inform that blind and other disabled employees are more vulnerable to Corona virus disease in view of their extensive dependence on 'touch'. It is neither in their interest nor in the interest of other employees to insist the attendance of blind and other disabled employees in the offices even if they are working in essential services.

2. The matter has been considered by the Government and it has been observed that in case blind and disabled employees are not exempted from attending the offices in the wake of spread of Corona virus, including those working in essential services such as Health, Municipal Corporations, Police etc., they would not only risk themselves but could also potentially be harmful for co-workers as well. The persons with severe disabilities are therefore exempted from attendance
3. The Heads of Departments/Heads of offices are advised that while drawing up roster of staff the employees who are persons with severe disabilities may not be called for duty.

All concerned are directed to comply with these instructions/directions in letter and spirit.

Sir/Madam,

I am directed to refer to Government letter of even number dated 8.5.2020 on the subject noted above vide which it was advised that the persons with severe disabilities may not be called for duty.

2. The matter has been re-considered by the Government and it has been decided that the Government employees working on regular basis/contract/daily wages who are unable to walk having physical disability of 50% or above and also those who are blind from both eyes may be allowed to work from home, if necessary, otherwise may be exempted to attend office. This period will be treated as Duty for all intents and purposes.
3. All concerned are directed to comply with these instructions/directions in letter and spirit.
