The above promotions are subject to the following terms & conditions:-

1. The promotion of the above officials at Sr. No 3 to 11 who have been regularized under the Regularization Policy, 2014 are promoted as per CS Haryana instructions dated 13.06.2024 subject to the final outcome of Hon'ble Supreme Court in SLP No 31566 of 2018 and other concerned SLP.
2. The above promotion is, further, subject to the Haryana Education Department, National Cadet Corps (Group-C) Service Rules, 1991 and Amendment Rules, 2013 and all other rules and regulations and executive instructions issued or to be issued by the State Government from time to time.
They will be required to qualify the State Eligibility Test in Computer Appreciation and Applications (SETC). They shall not be entitled to earn any increment in their pay scale till they qualify the said test, failing which their services shall be dispensed with. Typing speed of 30 words per minute in English and 25 words per minute in Hindi is required to pass SETC test. If SETC Test is not clear, they will not be allowed to have annual increment until they pass this test. After passing the test, they will be allowed to have increment from the date following the day of test on which they passed the test, without payment of arrear of increment(s). Their date of increment will, however, not be postponed on account of his/ her failure to clear the test
3. These promotions are without prejudice to the rights of their senior employees. In case, any claim made by any senior is accepted at any stage in future, they shall be reverted to their original post from which they are being promoted.
4. These promotions are without prejudice to the disciplinary proceedings, if any, pending against their seniors.
5. In case, any vacancy against which they are being promoted, ceases to exist and there is no other vacancy of the post on which they are being promoted available, the junior most employee shall be reverted back to his original post without any notice.
6. Their promotions are subject to review which may be exercised by any Court of Law/Govt. adversely affecting their promotion.
7. They will remain on probation for a period of one year, which can be extended as per applicable Service Rules.
8. In case, they do not join the promotional post within 15 days, from the date of communication of this order, their promotion shall stand cancelled.
9. The promotion orders are subject to the modifications/corrections in case, any discrepancy/gap is found at later stage.
