Sr. No.	Month	Activities
1.	August, 2025	Inter/Intra college Poster and Slogan making competition on Drug awareness
2.	September, 2025	Inter/Intra college Debate/Declamation competition on Drug awareness
3.	October, 2025	Organizing Skits (Nukkad Natak) to create mass awareness on Drugs and its disadvantages
4.	November, 2025	Exhibitions of Posters & Slogan for sensitizing the students about the drugs
5.	December, 2025	Inter/Intra college Power point presentation competition on Drug awareness
6.	January, 2026	Drug Awareness Rally using posters and slogans for community awareness
7.	February, 2026	One Day Seminar & Awareness program on "Drug Abuse Prevention"
8.	March, 2026	Organizing Nukkad Natak at the prominent places in the city to create mass awareness on Drugs

It is further intimated that "**Anti-Drug Awareness Cell**" consists of Coordinator, Two Senior faculty member, three students of different streams/classes, shall be constituted in all Govt. Colleges/Govt. Aided Private Colleges with the objective to educate the students/ community about danger and negative effects of drug use and to create

a drug free environment in the Govt. Colleges/Govt. Aided Private Colleges and promote healthy living among students.

It is intimated that ATR for above monthwise activities shall be submitted through google form. The link will be intimated separately.


