Subject : Regarding opening of Portal of HKRNL.

Sir/Madam,


I am directed to invite your attention to the Government instructions of even number dated 13th August, 2024 on the subject cited above vide which decision was taken to open portal window of HKRNL upto 30.09.2024 and all the Heads of Departments/ Boards/Corporations etc. were requested to upload the data of eligible contractual manpower on the portal of the HKRNL by 30.09.2024.

2 Numerous requests of departments/ Boards and Corporations are being received for porting the data of contractual employees to get the benefit of job security under the Haryana Contractual Employees Job Security Act, 2024. The matter has been examined by Government and it has been decided to open the portal of HKRNL once again for porting the data of contractual manpower only for those who were engaged on or before 31.03.2022 and are still in service.

3 Further, it has also been decided that such portal window shall be opened by HKRNL only for such contractual employees of Departments/Boards/Corporations etc. till 20.02.2026, for which approval of Finance Department has been obtained for porting the contractual employees as per provision in Para 8.1 of the Deployment of Contractual Persons Policy, 2022. The copy of approval of Finance Department shall be uploaded to HKRNL Portal and then the HKRNL shall open the portal for the concerned department.

4 This issues with the approval of Competent Authority.


