**Subject:- Provisional appointment to the post of Assistant Professor (College Cadre), HES-II Group "B" in the subject of Physics.**

On the recommendation of Haryana Public Service Commission, Panchkula received vide No. RG 18/2024/9254 dated 22.01.2026, the Governor of Haryana is hereby pleased to appoint above named candidates as Assistant Professor (College Cadre), HES-II Group "B" in the subject of **PHYSICS** in an officiating capacity in the pay scale of Rs. 57,700-1,82,400/- plus usual allowances sanctioned by the Govt. from time to time, on the following terms & conditions:-

1. The appointment is purely temporary and on provisional basis.

2. The appointment is against a temporary post. The confirmation against substantive post shall be considered on the basis of seniority & record of service as and when such post is available.
3. You will be on probation for a period of two years in the first instance & your probation period can be extended, if, in the opinion of the Govt., it is necessary to do so.
4. Till you are confirmed, your services are liable to be terminated at any time without assigning any reason by giving one month's notice or one month's salary or salary for such period for which the notice falls short of one month, as the case may be, in lieu thereof, and in case you desire to resign from service you will have to give one month's notice or deposit one month's salary or salary for such period by which the notice falls short of one month in lieu thereof, as the case may be.
5. You will have to take an oath of allegiance to the Constitution of India and affirm that you do not have more than one living spouse in case you are married.
6. In case you are married, you will have to furnish a declaration to the Head of Department that you will not taken/give any dowry after marriage. The declaration should be signed by your wife/husband, father and father in law, as per Chief Secretary, Haryana letter No. 18/1/2004-2GSI dated 21-02-2006.
7. If you are unmarried, you will have to take an oath of allegiance to the Constitution of India and affirm that you do not give or take or abet the giving or taking of dowry, or demand, directly or indirectly from the parents or guardians of the bride or bridegroom, as the case may be, any dowry, as per Chief Secretary, Haryana letter No. 18/1/2004-2 GSI dated 21-02-2006.
8. You will not be allowed to apply for any post outside the Department for a period of atleast five years.
9. You shall have to serve in rural area/small town for a minimum total period of five years out of which atleast three years should be prior to placement in senior scale and at least two years prior to award of selection grade. You shall, however, be free to opt to do the service in rural area/small town for a period of five years at a stretch prior to the award of senior scale. However this tenure is subject to any amendment in the existing provisions, to be made at subsequent stage, if any.
10. Your seniority will be fixed in accordance with the Departmental Rules.
11. Your services will be governed by Haryana Education (College Cadre) Group "B" Service Rules, 1986 as amended from time to time.
12. In other matters, not specifically mentioned in this communication, you will be governed by the Haryana Civil Service Rules, 2016 as applicable to Haryana Govt. Employees and such orders/instructions as may be issued by the Govt. from time to time.
13. You will be covered by the "New Defined Contributory Pension Scheme" as per F.D. Notification dated 28-10-2005.
14. The appointment order is subject to final outcome of CWP No. 8615/2025, 21551/2024, 25801/2025, 19003/2025, 18854/2025, 28574/2025, 28611/2025, CM - 13332-CWP-26553/2025, CM-14337-CWP 21773/2025, 25459/2025, CM-14574-

CWP 29012/2025, 29363/2025, 29166/2025 pending before the Hon'ble Punjab and Haryana High Court. Further the appointment order is subject to review on the basis of the outcome of various court case/writ petitions that might have been filed are pending in any court or may be subsequently filed.

15. After joining you are required to submit four copies of character and antecedents verification forms (Attestation Form) duly filled in within ten days either in person or through Registered post in the office of Director General Higher Education, Haryana at Panchkula through Principal concerned. 16. At any stage, if the certificate/s produced by you, is/are found to be bogus or defective, your services shall be terminated. Notwithstanding anything contained in this appointment letter, your appointment is subject to condition that if you are found unfit/unsuitable on the basis of medical report, your services shall be terminated forthwith without prejudice to any other terms and conditions.
