ORDER

The Governor of Haryana is pleased to promote Dr. Taruna, A.P. in English, Govt. College for Women Sector-14, Panchkula to the post of Principal/Deputy Director (Group-'A' College Cadre) in Level-14 of the 7th Central Pay Commission (CPC) plus allowances admissible as per rule on provisional basis with immediate effect with place of posting at Directorate of Higher Education, Haryana, Panchkula against vacancy and subject to condition that nothing adverse may be found in the ACRs of the year 2015-16 of the promoted said Principal/Deputy Director with following conditions:-

1. This promotion is without prejudice to the right of her seniors.
2. This promotion is without prejudice to the disciplinary proceedings pending against seniors.
3. This promotion is further subject to Government/Court decision adversely affecting this promotion.
4. In case the vacancies against which she is being promoted cease to exist and there are no vacancies of the post on which she is being promoted, she will be reverted to their original post without any notice.
5. The promotion order is subject to the modification/Correction in case of any in-advertent discrepancy/gap that may be found at later stage.
6. The promotion is further subject to the condition of finalization and any adverse remarks regarding integrity and overall assessment for the period mentioned against her name.
7. She will remain on probation for a period of one year which can be extended as per Service Rules.
8. The post of Scheduled Castes category has been kept reserved to the extent of 20% as per notification No. 22/56/2023-5HR-III, dated 07-10-2023.
9. She is directed to join her new assignment immediately. The officer on promotion, if she does not join her new assignment within 15 days from the issuance of the promotion order, her promotion shall be withdrawn/rescinded and she will not be considered for promotion for at least for one year from the date of issuance of this order as it will be treated as forgoing of promotion.
