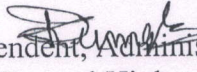

Subject:- Grant of general relaxation in Rule 6.24(4) and 6.24(7) of Pb. Civil Services Rules, Volume-II in cases where notional increment has been granted vide FD's instructions No. 6/44/2024-4PR (FD)/1697 dated 17.09.2025 as clarified on 02.06.2026.

Sir/Madam,

I am directed to invite your attention towards FD's instructions No.6/44/2024-4PR(FD)/1697 dated 17.09.2025 as clarified on 02.06.2026 (copies attached) whereby one notional increment has been allowed as per details contained therein.

2. Numbers of cases of pensioners of the State Government are being received in Finance Department through Administrative Departments, who had been retired prior to 19.07.2016 i.e. before the applicability of Haryana Civil Services (Pension), Rules 2016 and they have been granted notional increment for "pension" only. In such cases, relaxation in Rule 6.24(4) or 6.24(7) of Pb. Civil Services Rules, Volume-II, as the case may be, is being sought on case to case basis for fixation of pension.

3. After due consideration it has been decided to grant general relaxation in Rule 6.24(4) and 6.24(7) of Pb. Civil Services Rules, Volume-II which will be applicable for the employees/retired who have been granted notional increment as per FD's instructions No.6/44/2024-4PR(FD)/1697 dated 17.09.2025, subject to following conditions:-

- i. Administrative Departments will ensure that pay has been fixed strictly in compliance with FD's instructions No. 6/44/2024-4PR (FD) dated 17.09.2025 as further clarified vide instructions dated 02.06.2026 after verification by the SAS officer working in the department.
- ii. Administrative Departments will ensure that above relaxation is meant for "pension" only and arrear of pension in such cases is not paid prior to 01.05.2023.
- iii. In cases employees retired prior to 30.11.2007, relaxation is granted in Rule 6.24(7) and thereafter, relaxation is granted in Rule 6.24(4) of Pb. Civil Services Rules, Volume-II in view of FD's Notification No. 3/8/04-2Pension dated 30.11.2007 (copy attached).
- iv. The pay fixation and pension will be verified by the SAS Officer posted in the department strictly as per FD's instructions No.6/44/2024-4PR(FD)/1697 dated 17.09.2025 as clarified on 02.06.2026.
- v. This General relaxation will purely meant for cases in which notional pay has been fixed as per FD's instructions No.6/44/2024-4PR(FD)/1697 dated

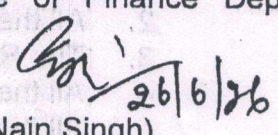
17.09.2025 as clarified on 02.06.2026 issued by Finance Department (Pay Revision Branch).

- vi. Administrative Department will ensure that other cases, other than covered under these instructions, will be sent to Finance Department (Pension Branch) as per previous practice.

4. This has the approval of competent authority.

5. You are requested to bring these instructions to the notice of all concerned.

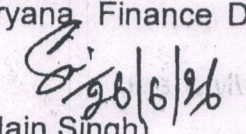

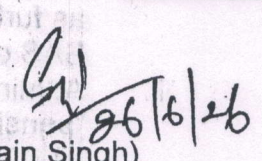
