

Subject:- Providing Records to State Vigilance Bureau in time.

Please refer to memo No. 9/17/1996-Vig-1 dated 16.10.1996

on 17.02.2013 and 12.02.2021 on the subject referred above.

It has been brought to notice of the Government that in a number of instances, various Departments of the Govt. (both in the Districts and at headquarter) do not provide relevant record that is required by the State Vigilance Bureau, Haryana while conducting enquiries and investigation of cases. This undue delay (at times deliberate) in handing over the records has an adverse impact on the progress and eventual finalization of various inquiries cases pending with the State Vigilance Bureau. Besides, it has also been noticed that in some cases, only partial and incomplete records are supplied despite repeated reminders from the State Vigilance Bureau.

This tendency for partial/incomplete supply of information to the State Vigilance Bureau has been viewed seriously by the Government. Accordingly, it is hereby directed that such records as are required by the State Vigilance Bureau shall be handed over to it at the earliest. If there is any genuine difficulty in providing the relevant records, efforts should be made to address those issues amicably and ensure that the requisite records are provided without any undue delay. In case incomplete record is provided to State Vigilance Bureau, in future, strict disciplinary action must be initiated against those responsible.

The above instructions shall be immediately communicated by all the Head of Departments to their respective subordinates and the concerned officers be adequately briefed and sensitized in this regard. Please ensure immediate compliance of these instructions in letter and in spirit.
