**ORDER**

The Governor of Haryana is pleased to Promote (Deemed) the following Associate Professors with Benchmark Disabilities under the Persons with Disabilities (Equal Opportunities, Protection of Right and Full participation) Act, 1995 vide No. 22/59/2020-1GS-III dated 25.03.2022, 01.07.2022 & 11.07.2023 to the post of Principal/Deputy Director in H.E.S.-I, Group-'A' (College Cadre) in Level-14 of the 7<sup>th</sup> Central Pay Commission (CPC) plus allowances admissible as per rule on provisional basis with effect from the date they give their respective joining at the Head Quarter as such, subject to following conditions:-

**CONDITIONS:-**

1. These promotions are without prejudice to the right of their seniors.
2. These promotions are without prejudice to the disciplinary proceedings pending against him/her.
3. These promotions are further subject to Government/Court decision adversely affecting these promotions.
4. In case the vacancies against which they are being promoted cease to exist and there are no vacancies of the posts on which they are being promoted, they will be reverted to their original posts without any notice.
5. The promotion order is subject to the modification/Correction in case of any inadvertent discrepancy/gap that may be found at later stage.
6. The promotion is further subject to the condition of finalization and any adverse remarks regarding integrity and overall assessment.
7. They will remain on probation for a period of one year which can be extended as per Service Rules.
8. All the above promotees are directed to give their joining at the Headquarter. Thereafter, the promoted Principals will continue to discharge their duties/work at their present place(s) of posting respectively till their regular posting orders are issued. The promoted Principals who do not give joining at Head Quarter within 15 days from the issuance of the promotion orders, their promotion shall be withdrawn/rescinded and they will not be considered for promotion for at least one year from the date of issuance of these orders as it will be treated as forgoing of promotion.
9. The fixation of pay of the aforementioned employees shall be effected only if he/she is found eligible for the same upon verification of facts from his/her service book and all relevant official record of the employee.
10. The aforementioned *deemed promotion* of the employee will be effective from the date mentioned against their respective names. In case of any discrepancy about the date of promotion, he/she shall submit a representation to the Directorate of Higher Education
