



Subject: - **Regarding Re-appropriation Orders of Government of Haryana for the year 2020-21.**

Kind attention is invited to the provisions contained in Para 14.5 (v) of Punjab Budget Manual (as adopted by Haryana Government) which provides that the Re-appropriation Orders are not permissible after the close of financial year. The delayed submission of Re-appropriation Orders leads to delay in finalization of Appropriation Accounts and the Principal Accountant General, Haryana is unable to adhere to the due date fixed by the office of the Comptroller & Auditor General of India in this regard. In view of this, the Re-appropriation Orders issued after 31<sup>st</sup> March, 2021 or received after 15<sup>th</sup> April, 2021 would not be incorporated by the Principal Accountant General (A&E), Haryana.

It is, therefore, requested that the details of Re-appropriation Orders for the year 2020-21 be furnished by 10<sup>th</sup> April, 2021 positively, so that all the Re-appropriation Orders for the year 2020-21 prior to 31<sup>st</sup> March, 2021 can be furnished to the Office of Principal Accountant General (A&E)/ (Audit), Haryana latest by 15<sup>th</sup> April, 2021.
