ORDER

NO. 21/109-2005 ME (5) DATED, PANCHKULA, THE. 17.05.2022

Whereas Sh. Suresh Kumar, Laboratory Attendant (suspended), Government College Baund Kalan (Charkhi Dadri) was found involved in a dispute with the people of his caste. FIR No. 52 dated 21.05.2009 was lodged against him under Sections 147, 148, 149, 323 and 307 of I.P.C. at Police Station, Baund Kalan, Bhiwani (Now Charkhi Dadri).

Whereas vide this office order no. 21/105-2009 ME(5) dated 07.08.2009, Sh. Suresh Kumar, Laboratory Attendant was placed under suspension under Rule-7.5 of CSR Vol-1 Part-1. The following charges were levelled against him:-

1. That he was found involved in a dispute with the people of his caste.
2. That FIR No. 52 dated 21.05.2009 was lodged against him under Sections 147, 148, 149, 323 and 307 of I.P.C. at Police Station Baund Kalan and he was in custody of District Jail Bhiwani since 09.06.2009.
3. Despite being a Government employee, he was found involved in the criminal case.

Whereas as per order dated 17.09.2012 passed by Sh. Abdul Majid, Additional Sessions Judge, Bhiwani in case no. 25 of 2009, Sh. Suresh Kumar, Laboratory Attendant (suspended) was sentenced Rigorous Imprisonment for a period of ten years under Section 307 of I.P.C.

Whereas the main case CRA No. 2867 –SB of 2012 titled as Suresh and Ors Vs State of Haryana is still lying pending in Hon'ble High Court and as per Hon'ble High Court order dated 09.09.2013 passed in CRM No. 39569 of 2013 and CRM No. 34523 of 2013 in CRA No. 2867-SB of 2012 the bail application was allowed and Sh. Suresh Kumar, Laboratory Attendant is on bail since Sep 2013 and had not completed the 10 years of sentence period awarded to him.

Whereas as per order dated 17.09.2012 passed by Sh. Abdul Majid, Additional Sessions Judge, Bhiwani in case no. 25 of 2009, **there was the clear involvement of Sh. Suresh Kumar, Laboratory Attendant in criminal attempt** and hence the action is required to be taken against him as per the provision laid down in **Article 311 of the Constitution of India, 1949, Haryana Civil Services (Punishment and Appeal) Rules, 1987 and Haryana Civil Services (Punishment and Appeal) Rule, 2016.**

Whereas, as per the facts produced above, Sh. Suresh Kumar, Laboratory Attendant (suspended) is hereby **removed from service with immediate effect**, as per provisions of Article 311(2) (a) of the Constitution of India and Rule 7(A) (16) of Haryana Civil Services (Punishment & Appeal) Rules, 2016, without giving any opportunity on the basis of his conduct which has led him convicted on a criminal charge under Section 307 of I.P.C.

I pass the order accordingly.
