I am directed to invite your kind attention and refer to Haryana Government Home Department bearing letter No. 35/03/2021-1HG-III dated 28.04.2022 on the subject noted above. The post of Clerks under 5% quota under ex-gratia scheme under the Haryana Civil Services (Compassionate Financial Assistance or Appointment) Rules, 2019 are not available in Police Department. The 10 senior candidates (dependents of deceased employees) are to be given appointment as Clerk on compassionate grounds in any other Department of Haryana, regarding posts of Clerk of Ex-gratia quota lying vacant along with their categories.

3. It has come to the notice of the Government that various department have still not submit the above information.

4. In view of above, it is therefore, again requested to intimate that how many posts of Clerks under ex-gratia quota under the Haryana Civil Services (Compassionate Financial Assistance or appointment) Rules, 2019 are lying vacant alongwith their categories in their department, so that the employment/appointment could be given to the dependents of the deceased employees under ex-gratia scheme under the Haryana Civil Services (Compassionate Financial Assistance or Appointment) Rules, 2019 as early as possible. The Department who have already been submitted above information they are no need to take action regarding this notice.
