

Subject: Regarding filling up the post of Designated Officers/Food Safety Officers on deputation basis from other departments of Haryana Government due to acute shortage of D.Os/FSOs in Food & Drugs Administration Department.

Please refer to this office circular letter no. 13/51-1Food-2021/8262-8268 dated 18.11.2021 on the subject cited above.

Vide above referred letter FDA Department has issued circular with request to send consent of Officers/Officials of your Department having the requisite qualification i.e. a degree in Food Technology or Dairy Technology or Biotechnology or Oil Technology or Agricultural Science or Veterinary Sciences or Bio chemistry or Microbiology or Master's Degree in Chemistry or degree in Medicine from a recognized university, or any other equivalent/recognized qualification notified by the Central Government, who desires to work as whole time Designated Officers and Food Safety Officers in Food and Drugs Administration Department, Haryana on deputation basis for two years or till joining of regular incumbent whichever is earlier. But no response has been received so far.

You are again requested to send the consent of willing Officers/Officials with required details/documents for deputation to the post of Designated Officer/Food Safety Officer in FDA Department Haryana for two years or till joining of regular incumbent whichever is earlier, within 15 days to this office. So that further action could be taken in the matter.
