



It has been learnt that large number of employees have now validated their Service Books in HRMS portal since 1.12.2022. Hence, it has been decided that DDOs concerned after verification thereof, may release salary of those employees/checkers twice in a week who have validated/completed their service Books on HRMS. Further, before preparing the salary bills for the payment of salary of the month of December, 2022 to be paid in month of January, 2023, DDOs concerned must ensure updation/validation of Service Books on HRMS system by all Employees/Checkers concerned under his/her control, otherwise salary bills of employees/checkers who have not validated their Service Books on HRMS Portal will not be prepared.
