
Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that superseding all existing panels of Inquiry Officers as per instructions issued vide letter No. 48/1/2008-3Vig (II), dated 15.03.2022, a panel of 06 retired officers enclosed herewith as (Annexure-A) is issued for conducting departmental enquiries under the Haryana Civil Services (Punishment & Appeal) Rules, 2016. The departments while issuing orders of appointment of the Inquiry Officer may send an endorsement to the office of Inquiry Officer, Vigilance, Haryana, Room No. 49-50A, 30 bays Building, Sector-17-C, Chandigarh.

All the Administrative Secretaries and the Heads of Departments should follow the above mentioned Government instructions dated 15.03.2022 regarding terms & conditions and Honorarium, etc. of Inquiry Officer. The list of empanelled Inquiry Officer is also applicable to Boards/Corporations/Public Sector Undertakings etc. of Haryana. In case of ongoing inquiries the competent authority shall have the option to continue with the Inquiry Officer already appointed or transfer the case to any Inquiry Officer out of panel of Inquiry Officers (Annexure-A).
