



**Subject: Regarding engagement under Outsourcing Policy Part-II.**

Sir/Madam,

I am directed to invite your kind attention to Government instructions No. 16/07/2015-3GS-II, dated 28.09.2021 vide which the State Government has decided to stop all fresh recruitment/engagement under Part-I and Part-II of the Outsourcing Policy with immediate effect.

2. Now, the matter has been re-considered and it has been decided to revive the Outsourcing Policy Part-II, only for those employees who had been appointed under Outsourcing Policy Part-II against sanction posts and were in service as on 28.09.2021. They will continue till regular appointments are made against these posts or till 31.12.2022, whichever is earlier.
