

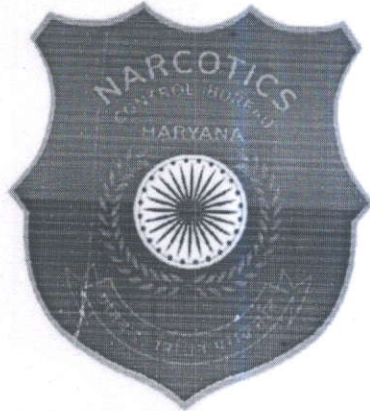

## Chapter-2

**DHAKAD** Programme**Introduction:**

The "*Dhakad*" Programme aims to prevent drug abuse among the youth, particularly students by providing knowledge, including behavioural skills and developing a support system for self and group monitoring in order to prevent them from falling prey to drug abuse.

**Vision:** To create a mechanism for identification, supervise, support and de-addiction of drug abusers.

**Who is a *Dhakad*?**

"*Dhakad*" is a friend/companion one can rely on for help, care, assistance, and support.

**Who is "*Senior Dhakad*"?**

Class teacher shall be the "*Senior Dhakad*" who will form *Dhakad* groups of 5 classmates for implementation of this programme.

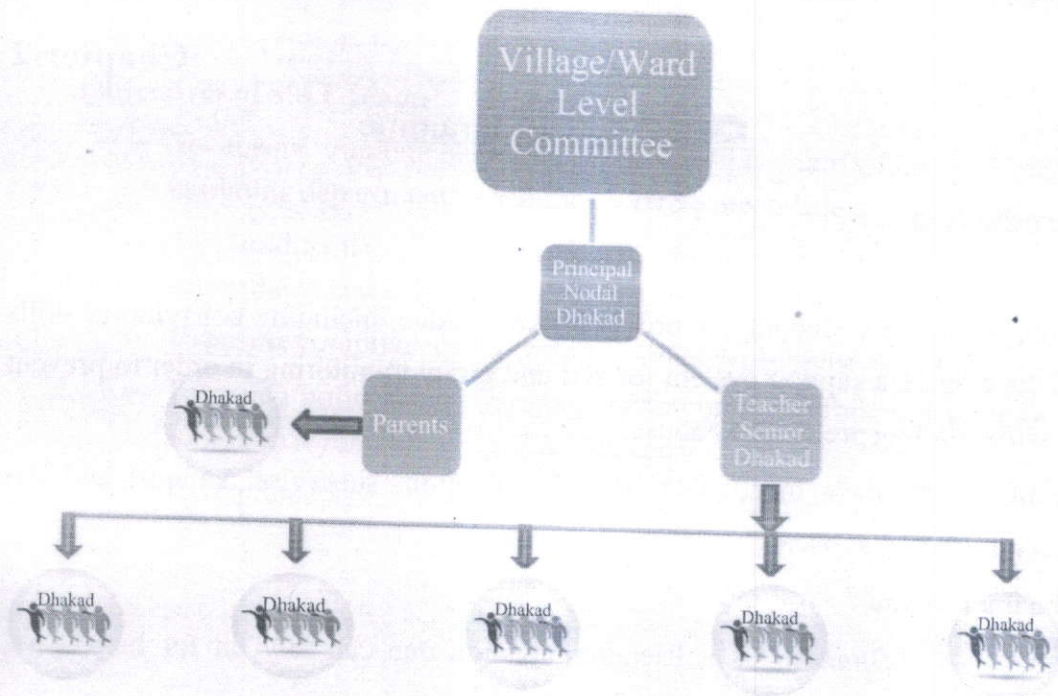
**Who is "*Nodal Dhakad*"?**

Principal/Headmaster of the School and in case of College/University Head of the Department shall be appointed as "*Nodal Dhakad*" for supervision and implementation of this programme.

**Why "*Dhakad*" Programme:**

The *Dhakad* programme aims to prevent drug abuse among the youth, particularly students by providing a platform where young students are involved in more than just token ways. *Dhakad* know how to communicate with their peers in a way that makes sense. It aims to increase interaction among students for achieving better academic performance, developing life skills and enabling them to lead a healthy and drug free life.

**Working structure of *Dhakad* Programme:**

Programme will be implemented at School, College and University levels. As per this program, a group of five students shall be formed by class teacher. Member students of this group will look after each other and in case of any behavioural change, noticed in any "*Dhakad*" due to drug abuse that shall be reported to class teacher known as "*Senior Dhakad*". After receiving information *class teacher/Senior Dhakad* will interact with the concerned *Student/Dhakad*.

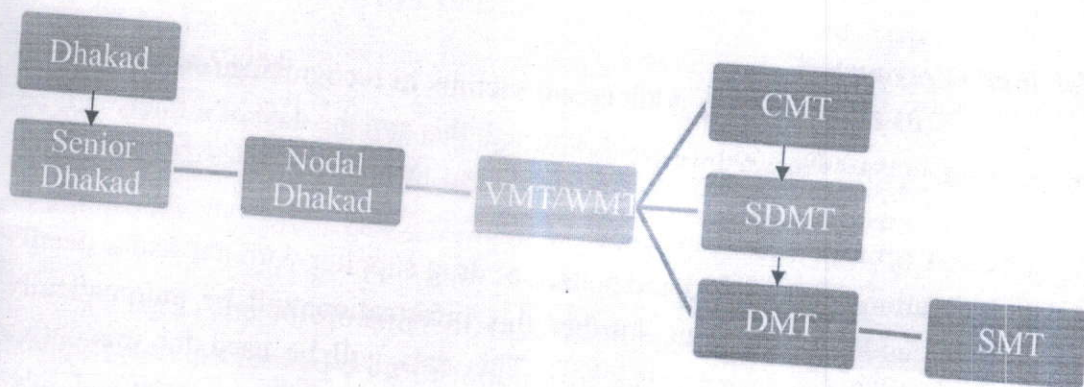
Principal/Headmaster of the School and in case of College/University Head of the Department shall be appointed as "*Nodal Dhakad*" for supervision and implementation of this program. Senior Dhakad will report to the Principal/Headmaster of the School and in case of College/University Head of the Department for de-addiction of the students who are dependent on drugs. This information related to drugs addicts further will be shared with Village/Ward Mission Team and health department, so that addicts may be facilitated for

counselling and de-addiction. Further the information of drug addicts will be filled by Village/Ward Mission Team and health department, through Prayass app prepared for this purpose by HSNCB, which will help to identify drugs traffickers, there source of drug, category of drug consumed and process of treatment related to de-addiction of addicts.

### Supervision and Monitoring of "Dhakad" Program:

The implementation and supervision of this program shall be regulated by the State Mission Team, District Mission Teams, Sub-Division Mission Teams, Cluster Mission Teams and Village/Ward Mission Teams, structure already designed at different levels within the State for identification, counselling, treatment, rehabilitation and de-addiction of addicts. The flow chart of Supervision and Monitoring of "Dhakad" Program will be as under:-
